
Our GOAL to educate the children who are orphaned and abandoned in the community.


ARTICLE 3: CONSTITUTION AND LEGALITY


This constitution belongs to the organization based here in referred to as **GOD'S SUPPORT OPHANAGE ministries as law and shall bind the founders of the organization.**

ARTICLE 6: FUNCTIONS AND POWERS OF THE EXECUTIVE BOARD.

The Board of Directors shall;

- (c) Take care of the smooth running of the organization.
- (d) Have powers to call an emergency meeting.

ARTICLE 7; DISQUALIFICATION OF BOARD MEMBERS

- ❖ A member shall be disqualified when his absent without permission of the Board from all their meetings held within a period of six consecutive months and the Board resolve that his or her office to be vacated.
- ❖ When a member become incapable by reason of mental disorder, lines or injury of managing and administering his /her own affairs.

A director who is found to;

- ❖ Have abused his office
- ❖ Been declared bankrupt
- ❖ Misconduct
- ❖ Misbehavior

ARTICE 8; FUNCTIONS OF THE EXECUTIVE DIRECTOR.

(a)The Executive Director shall;

- ❖ Arrange all the meetings of **God's Support Orphanage Ministries Uganda** and the minutes thereof.
- ❖ The Director will serve as the overseer of the Board of executive committee.
- ❖ Shall maintain custody of the organization's cheque books.
- ❖ Authenticate the seal of organization with his signature.

(b)The chairperson shall;

- ❖ Powers to convene and preside over executive and annual general meeting of the organization.
- ❖ Shall be the overall head of the organization.
- ❖ Shall delegate hiss duties to any other members of the executive committee but such delegation shall be approved by not less than two thirds of the members of the executive committee.
- ❖ Shall also ensure that the organization complies with all requirements of the non government organization registration and the provisions of his constitution and any by laws and regulations made here under.

(c) General Secretary shall;

- ❖ Shall prepare and keep an inventory of all properties and assets of the organization.

(d) The Treasurer shall;

Shall be responsible for preparing all financial affairs including preparation of the statements of income and expenditure and of the budget which shall be presented to the executive committee and the annual general meeting

ARTICLE 9; MEETINGS GENERAL MEETINGS,

The annual general meeting shall be held twice in a every year.

The board of Directors shall met whenever they need a raise but they shall have regular correspondences through telephones emails, skype.

All members shall claim victory of any position with at least 51% of the votes


TERMS OF OFFICE


Elected members shall serve three years in office and will help in the preparation of future election.


ARTICLE 10; FINANCE.






